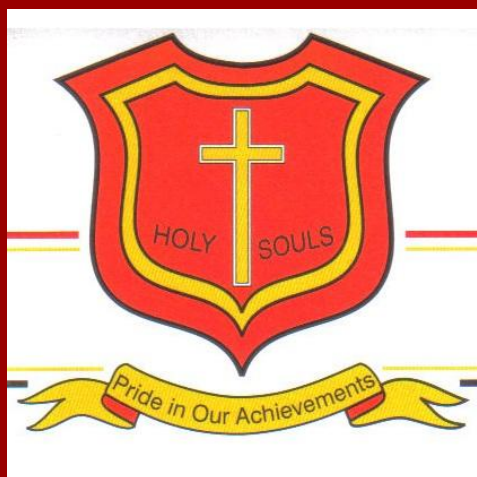

Annual review

Admission Policy for 2027/2028

These procedures apply to admissions to Holy Souls Primary School, which is a Roman Catholic Voluntary Aided School, provided by the Diocese of Salford and is maintained by Blackburn with Darwen Local Authority. The school's Governing Body is the Admissions Authority and is responsible for taking decisions on applications for admissions.

Applications for admission to the school for September 2027 should be made on the home Local Authority's common application form enclosed with the Local Authority's brochure or on-line. These applications are available between 1st September 2026 and 15th January 2027. After the closing date of 15th January 2027, the admission committee will allocate places. All preferences listed on the common application form will be considered on an equal basis with the following set of admission criteria forming a priority order where there are more applications for admissions than the school has places available.

Letters informing parents of whether or not their child has been allocated a place at Holy Souls will be sent out by the Local Authority by 16th April 2027. Parent(s)/carer(s) of children not admitted will be informed of the reason and offered an alternative school place by the Local Authority.

For the academic year, 2027/2028, the admission number is: 30.

Children who have an Education, Health and Care Plan where the named school is Holy Souls RC Primary School, will be admitted first. Thereafter, if the demand for places exceeds the number of places available, priority will be given to the following categories listed below in priority order:

1. Baptised Roman Catholic looked after children and Baptised Roman Catholic previously looked after children (see note a)
2. Baptised Roman Catholic children, who have a sibling in school at time of application and admission (see note b)
3. Baptised Roman Catholic children resident in the parish of St Alban's and living in the following catchment areas (see notes c and d)
4. Other baptised Roman Catholic children
5. Looked after children and previously looked after children (see note a)
6. Other children who have a sibling in the school at the time of application and admission (see note b)
7. All remaining applicants

Please note: each Roman Catholic applicant will be required to produce a baptismal certificate unless they were baptised at Holy Souls Church, where baptismal records will be checked.

Notes:

- a. A 'looked after' child is a child who is (a) in the care of a Local Authority or (b) being provided with accommodation by a Local Authority in the exercise of their Social Services functions (see the definition in s.22(1) of the Children Act 1989) at the time of making an application to the school. A previously looked after child is a child who (a) was 'looked after' but ceased to be so because they were adopted or became subject to a child arrangements order or special guardianship order or (b) a child who appears (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted. An 'adoption order' is an order under the Adoption Act 1976 (see Section 12 adoption orders) and/or the Adoption and Children Act 2002 (see Section 46 adoption orders). A 'child arrangements order' is an order settling the arrangements to be made as to the person with whom the child is to live under Section 8 of the Children Act 1989 as amended by Section 14

of the Children and Families Act 2014. Section 14A of the Children Act 1989 defines a 'special guardianship order' as an order appointing one or more individuals to be a child's special guardian (or special guardians). A child is regarded as having been in state care outside of England if they were in the care of or were accommodated by a public authority, a religious organisation, or any other provider of care whose sole or main purpose is to benefit society."

- b. "Sibling" includes half, step, foster and adopted siblings or the child of the parent/carers partner who live at the same address.
- c. Where a child lives with parents with shared responsibility, each for part of a week, the child's "permanent place of residence" will be determined as the address of the parent who normally has responsibility for the majority of school days in a week. Where care is split equally the household in receipt of the child benefit will determine the address used.
- d. The boundaries for the catchment areas are shown on the attached map which forms part of these admission arrangements.
- e. Where twins/children of multiple births request admission where one of the children is the 30th child admitted the other child or children may also be admitted. This also includes exceptions under the school admissions code.

Tiebreaker

If in any one category there are more applicants than places available, priority will be given based on proximity to the school, nearer addresses having priority over more distant ones. The distance will be measured in a straight line ("as the crow flies") from the school gates to the family home, using a computer system. If, after measuring distances it is still not possible to decide on the child to be offered admission (e.g two children living in the same building) then the Local Authority's system of a random draw will determine which child(ren) receive the offer(s). The draw is carried out automatically by the local authority's computerised system.

It is the duty of Governors to comply with class size limits at Key Stage 1. This means that the school cannot admit more than 30 children in Key Stage 1 classes, except as in (note e).

Children who apply for a place and are not admitted will have their names placed on Holy Souls waiting list which is kept until the child leaves primary school. The order of names on the waiting list is based on the admission criteria and not the date of application. This may mean that a child may join the waiting list and have a higher priority than children who have been on the waiting list for some time. If a place becomes available within the admission number, the child whose name is at the top of the list is offered a place. This is not dependent on whether an appeal has been submitted. Looked after children or previously looked after children and those allocated a place at the school in accordance with the Fair access protocol will take precedence over those on the waiting list.

Late applications

Where there are extenuating circumstances for an application being received after the closing date for applications (15th January 2027), and it is before the governors have established their list of pupils to be admitted (February 2027), then it will be considered alongside all the others. Otherwise, applications which are received after the closing date for applications will be considered after all the others and placed on the waiting list in order according to the criteria.

In-year admissions

The governing body will participate in in-year coordinated admission arrangements in 2027-2028. Anyone wishing to apply for an in-year place at Holy Souls should contact Blackburn with Darwen Place Planning & Admissions team (Email - admissions@blackburn.gov.uk, Telephone 01254 666605). In-year applications will be considered when they are received, and places offered if available. If there is already a waiting list for that year group, then the child's name will be added to

the waiting list. If more applications are received at a particular time than there are places available then published oversubscription criteria will be applied to those applications and places offered accordingly. Those who are not offered places will have their names added to the waiting list.

Fraudulent applications

Where the Governing Body discovers that a child has been awarded a place as a result of an intentionally misleading application from a parent/carer (e.g. giving a false address in order to gain an advantage), then the offer of a place may be withdrawn. The application will be considered afresh, and a right of appeal will be offered if a place is refused,

Appeals

Where the Governors are unable to offer a place because the school is oversubscribed, parent(s)/carer(s) have the right to appeal to an Independent Appeal Panel, set up under the School Standards and Framework Act, 1998 as amended by the Education Act 2002. Appeal forms are available from the school office. Appeal forms for September 2027 Reception places should be completed and returned to the school by 15th May 2027.

Deferred admission

If your child is due to start school during the next academic year, it is important that you apply for a place for September. If your child's fifth birthday is between the months of September and December, then, if you wish it, admission may be deferred until January; if it is between January and August, then admission may be deferred until the start of the summer term though it is likely to be in your child's interest to start no later than January. If you defer a summer born child starting school completely during Reception year, they will lose the place and will have to reapply. You may request that your child attend part-time until later in the school year but not beyond the point at which they reach compulsory school age. A child reaches compulsory school age on the 31 December, 31 March and 31 August following their 5th birthday, whichever comes first.

Admission of children outside their normal age group

Parent(s)/carer(s) may seek a place for their child outside of their normal age group, for example, if a child is gifted and talented or has experienced problems such as ill health. Parent(s)/carer(s) of a summer born child (born between 1 April and 31 August) may choose not to send that child to school until the September following their fifth birthday and may request that they are admitted out of their normal age group - to reception rather than year 1.

Children who are already of school age

Parent(s)/carer(s) must submit their written request for admission out of the normal age group to the Governing Body. If their request is agreed and a place is available in the requested year group, the child will be admitted.

Children seeking admission to reception in the September after their fifth birthday

Parent(s)/carer(s) will need to submit a normal Common Application Form (CAF) to the Local Authority (in writing or online) for admission into the normal age group at the same time as they submit a written request to the Governing Body for their child to be admitted out of the normal age group.

Please note: This Governing Body will not honour a decision made by another admission authority on admission out of the normal age group. Parent(s)/carer(s), therefore, should consider whether to

request admission out of the normal year group at all their preference schools, rather than just their first preference school.

The Governing Body will make a decision on the request before the Primary national offer date if at all possible.

If the request is agreed, the parent(s)/carer(s) must make a new application for the next main admission round the following year, and their current application for the normal age group should be withdrawn before a place is offered.

If their request for admission outside the normal age group is refused, parent(s)/carer(s) must decide whether to accept the offer of a place for the normal age group that they receive from the Local Authority, or to refuse it and make an in-year application to the Governing Body for admission to year one for the September following their child's fifth birthday.

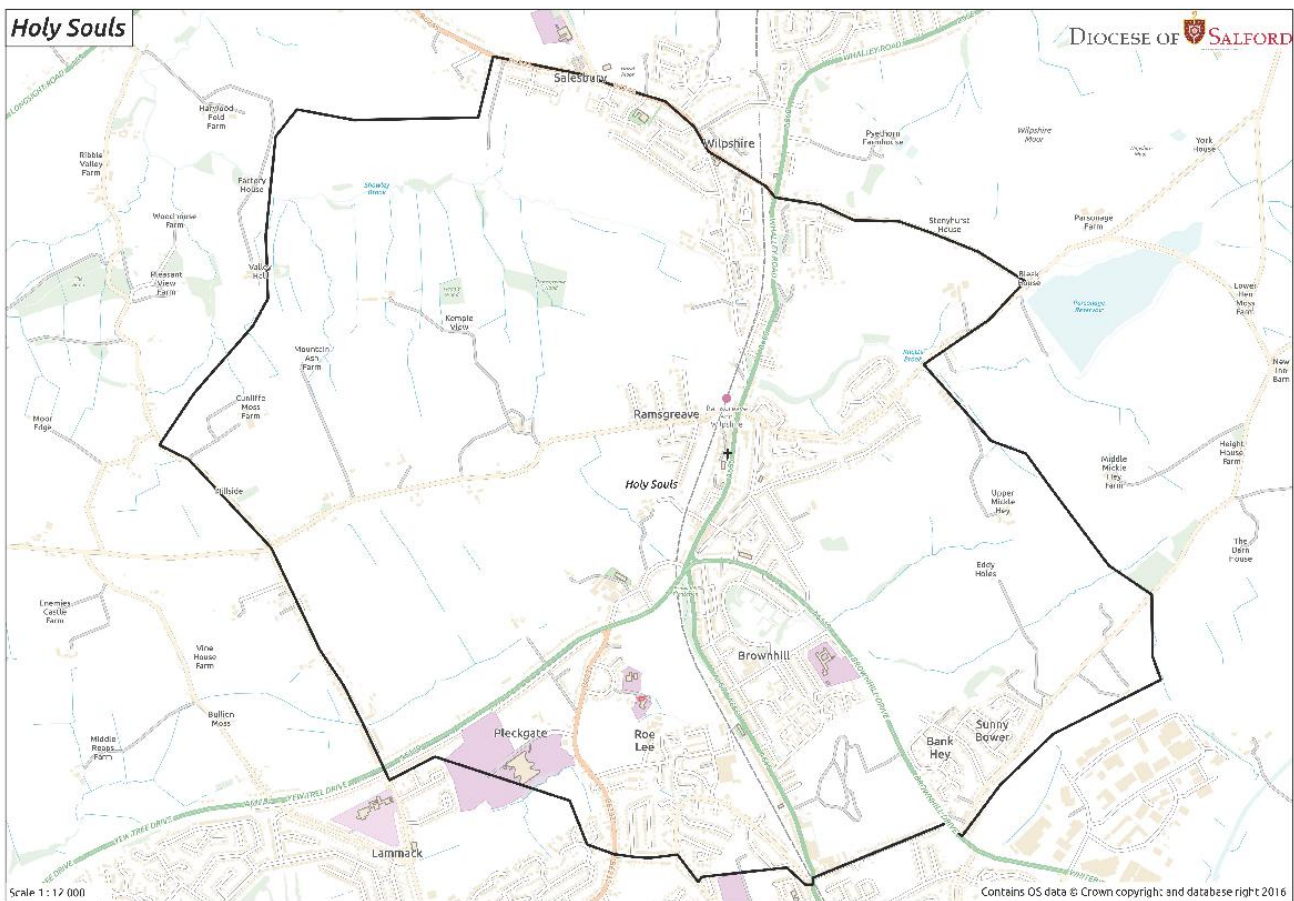
Making the decision

Parent(s)/carer(s) seeking admission of their child outside their normal age group must send their written request to the Governing Body. It is the responsibility of the parent(s)/ carer(s) to provide the Governing Body with all relevant information relating to this request, including the parent(s)/carer(s) views; information about the child's academic, social and emotional development; medical history and views of a medical professional (where relevant); whether the child would naturally have fallen into a lower age group if it were not for being born prematurely; and whether the child has previously been educated out of their normal age group.

The Governing Body is required to take into account the views of the Headteacher on the application as well as the information from the parent(s)/carer(s). The Governing Body will make their decision on the basis of the circumstances of each individual case, and in the best interests of the child concerned.

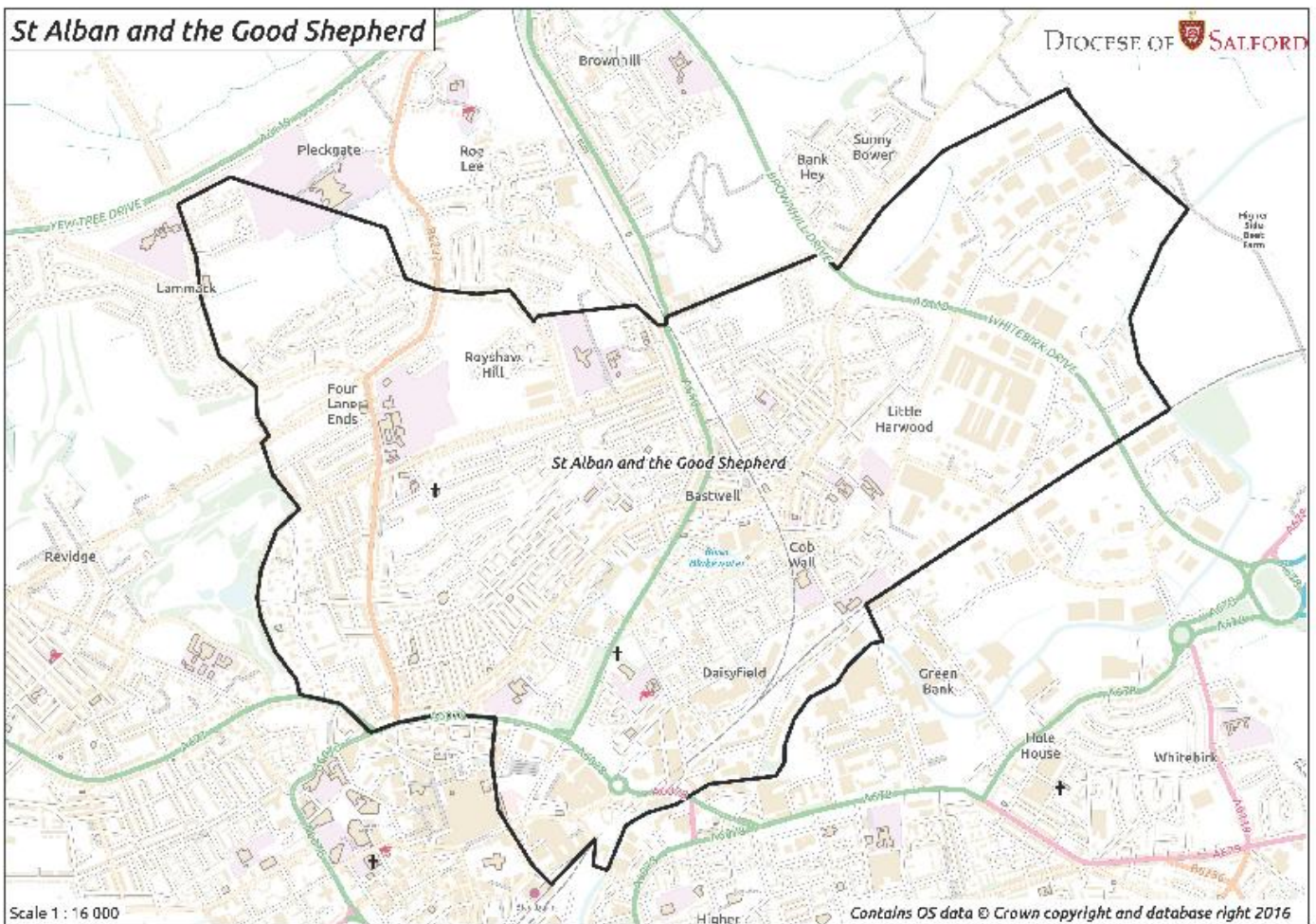
The Governing Body will then inform the Parent(s)/carer(s) of their decision on the year group the child should be admitted to and will provide the reasons for their decision.

Parent(s)/carer(s) have a statutory right to appeal to an independent admission appeal panel against the refusal of a place at a school for which they have applied. As the purpose of the appeals process is to consider whether a child should be admitted to a particular school, the right of appeal does not apply if they are offered a place at the school but it is not in their preferred year group. However, they may make a complaint about an admission authority's decision not to admit their child outside their normal age group.



2. Holy Souls, Blackburn

By Lammack Road north crossing Ramsgreave Drive A6119, and Barker Lane to the junction with Zechariah Brow and Higher Ramsgreave Road, N by Saccary La. and Anderton House, NW by Showley Brook and footpath S of Clayton Hey Farm, SE by Ribchester Rd., crossing Whalley Road A666 by Hollowhead Lane, Rishton Road, Blackburn Old Road to the Hyndburn – Blackburn with Darwen Boundary, and E by a footpath running parallel to and between Whalley Old Road and Cunliffe Road, N by Brownhill Drive, W by Clarendon Road, Whalley New Road, then W by a line behind 96 Openshaw Drive and by the Openshaw Drive, Pleck Farm Avenue, and across the playing fields of the new estate to Lammack Road.



2. St Alban and the Good Shepherd, Blackburn

From Blackburn Railway Station, along Railway Road, Ainsworth Street, Barbara Castle Way, Preston New Road, East Park Road, Brantfell Road and via the steps to and along Revidge Road, Paignton Road and by a beeline to Lammack Road, from Lammack Road SE across the playing fields to the new estate, including Swallowfields and Curlew Close but excluding Kingfisher Close and Aspinall Fold and by the footpath south of 53 Pleckgate Road to Pleckgate Road and by Pleck Farm Avenue and Openshaw Drive to the “circle” and then by a line behind 96 Openshaw Drive to Whalley New Road by the Skew Bridge, including Sycamore Road and Sycamore Close but excluding Briar Road and Rosewood Avenue, and by Clarendon Road to and along Brownhill Drive to and along the footpath running parallel to and between Whalley Old Road and Cunliffe Road, S along this boundary to the Leeds and Liverpool Canal and by the canal to the railway line and by the railway line to a point opposite Harwood Street, then by Harwood Street to and along the Liverpool and Leeds Canal to Cicely Street and by Cicely Lane to and along the railway to Blackburn Railway Station.
